## Dear Friends,



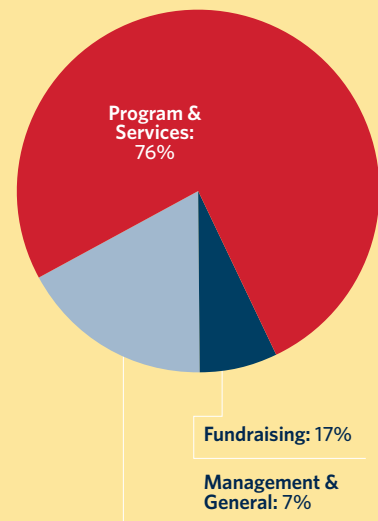

Total Revenue: \$2,844,446



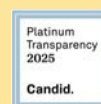
